Jason discussed the origins of the mint, economic context of the era as well the Masonic tradition of placing a casket of items in a cornerstone. Jason went on to address these basic questions.

Is the casket still there?

Are the contents intact?

What is the condition of the coins?

Where is the cornerstone?

Will the casket coins be recovered? Should they?
